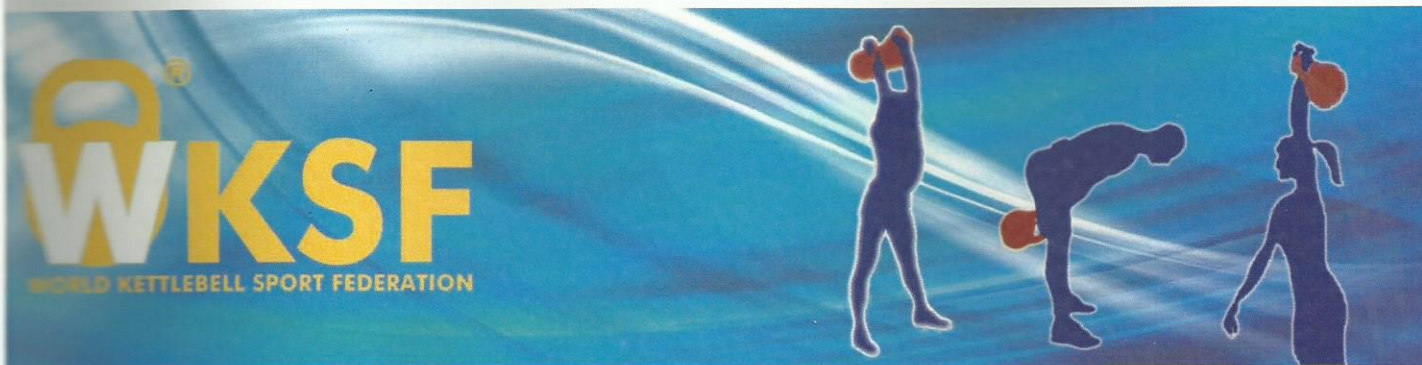

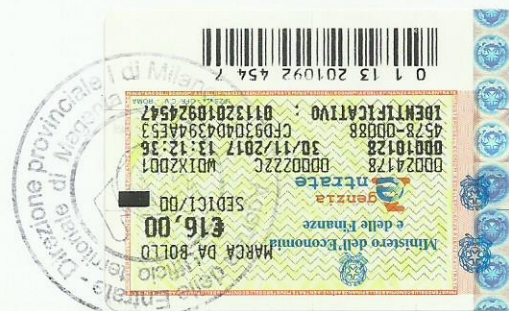

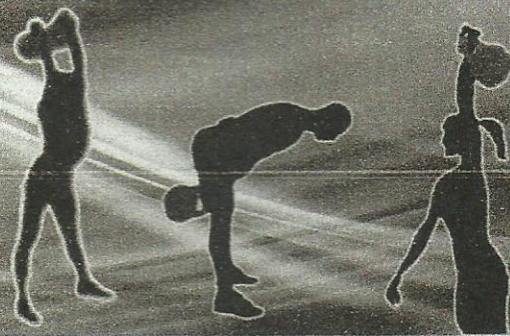


have formed the Sport Federation named : "WORLD KETTLEBELL SPORT FEDERATION"

- The FEDERATION is apolitical and no profit making
 - The "WORLD KETTLEBELL SPORT FEDERATION" aims to develop and disseminate sports activities with particular reference to the practice of sports discipline KETTLEBELL SPORT - KETTLEBELL LIFTING - GHIRI SPORT.
 - The founding members are the first group of Federation's member, they approve the Statute of the Federation and elect:
 - the President of the Federation: Mr. OLEH ILIKA
 - the members of the Executive Committee who will remain in charge for the first five years:
 - 1) IVAN DENISOV
 - 2) EDUARDO FONSECA
 - 3) MIKALAI KAITAN
 - 4) CHRISTIAN BORGELLO
 - 5) PER OLHANS
 - 6) SCOTT MCLAUGHLIN
 - 7) ALAN HUDSON
 - 8) YAREMUS ANDRIY
 - 9) GARY ROTHWELL
 - All elected accept the nomination, stating that they are not in any of the causes of ineligibility provided by the federal statute.
 - The President, Oleh Ilika, appoints:
 - the Vice-President: Mr. IVAN DENISOV
 - the Secretary-General: Mr. EDUARDO FONSECA
 both declare to accept the assignement
 - All the founding members will have the right to vote in the federation's assemblies, representing the Country for which they have signed this Act until, as provided by the Statute, a National Organization will be officially recognized as Federation member becoming the sole Member which will represent the Country.
- This rule does not apply to the Federation President, since he is super-partes, therefore he will retain the right to vote in all the assemblies.
