

As you know and may followed on social media/website, with a global concern, respecting all WHO and National guidelines, the WKSF Direction decided to cancel all presential competitions. The WKSF do not need or will not do any step can put in risk athletes, delegations, cities, countries and global health. Now, it's time to all we be responsible and also is a great opportunity to think about and prepare the future.

As you may know, the WKSF has own regulations for competitions, specific protocols and guidelines for several situations and have also regulations to accept and work with each Member (Representative). On our Statutes, is possible to read what our Direction Board and Executive Committee follow and try to all understand each decision. You can find important items on Statutes, as:

. ARTICLE 4 - APPLICATION FOR ADMISSION

- " Sports Organizations , such as sport Federations¹, sport associations², and sport clubs³ may be member of federation....."
- " In case more requests are received from same States, the President will, after careful evaluation of the same, submite to Executive Committee, for ratification, the name of organization that he considers to fit to join the Federation"

. ARTICLE 6 - DISQUALIFICATION OF MEMBERS

- "Voluntary dismissal"
- "overdue moratorium for more than 30 days from the expiration of the requirement of membership fee"
- " radiation deliberated by the majority of the members of the Executive Committee, pronounced against the member who commits actions demmed dishonorable within and outside the association, or wich, b its conduct, consitutes an obstacle to the good partneship of the partnership.
- "dissolution of the federation".

The importance to achieve the International recognition of WKSF and Kettlebell Sport, the WKSF has always the preference as first "Choice Decision" for Member, organizations that are work inside National Sport Governmental, then National Federations, after and above, any Association, after Clubs and at last decision, if doesn't exist any other candidature, is accept an Individual Person during 1 year, on until WKSF receives a national organization to replace the Individual Person (importante to refer that any Individual Persons doesn't have any vote on WKSF General Meeting and can't make any decision go forward on Kettlebell Sport future).

On United States of America, the WKSF did a choise to accept American Kettlebell Alliance as Official Member.


At 19th november of 2019, in Uzghorod - Ukraine at WKSF European Championships General Meeting, the President proposal to our Ecxecutive Committee was accepted, the Membership as representatives from 1 year to 3 years without annual renewal was accepted with 6 votes and unanimosly.

About United States of America, the Board and EC received the representative, Mr. Yuri Petunovs on our General Meeting and with 6 votes "Yes" was offical accepted AKA as USA Representative until 2022. However, we quote the last paragraphs of General Assembly Minute:

"With unanimosly of 6 votes, the Executive Committe voted to AKA continue as official Representative of USA during 3 years with condition of AKA stay under observation each year. It was deliberated as mandatory an extra effort of offical representative of USA to contact AKLU and create the conditions to promote an union of all lifters and possibility to participate in competitions to find the best lifters to represent USA official Team."

The WKSF Secretary received a candidature of AKLU organization to become USA Representative for next year (until 2022). The federation is very happy to see so many lifters inside boarders and high activity to promote our sport and during 2020, the Secretary and Mr. President were following all activity in USA as well. Not only the feedbacks and all AKA activity as AKLU activities.

The WKSF is working very hard with each Representative and also with several Governmental Institutes to help several representatives, even if is an Individual Person to register a club as if is an Association to be accepted inside National Sport Institute.
