## WKSF GENERAL MEETING MINUTE

At 8th June of 2024, at 19 pm at Hala Sportawa, University of Rzeszow, Str. Cicha 2/B, 35-326 Rzeszow, Poland. WKSF General Meeting was started to discuss and deliberate the following Orders of Day:

- 6) Disabled Commission meeting during the Championship.

It assumes the presidency, according to the statutes, Mr. Ilika Oleh, president of WKSF Executive Committe, wich saw the regulation of the convening of the assembly.

Are present at meeting 21 countries, representing: Greece, Hungary, Italy, Moldova, Poland, Portugal, , Ukraine, USA, Australia, Austria, Hong Kong. China, Canada, England, Scotland, Spain, Israel, Chile, Brazil, Sweden, Danmark, Germany and India.

The President procede to open the discussion of Orders of Day.

### 1) Report of the President on activities carried out by WKSF in the period 2023;

Mr. President presented the 1st Semester sharing iteh report with all member during the month on March. Available at the website and also shared directly to each member, was able to each member read the report.



#### 2) Presentation and approval of the 2023 financial statements;

With the 1st Semester Report available, the members were able to approve the 2023 financial statement. Asked to vote, the report was approved by majority.

#### 3) Presentation and approval of the 2024 budget;

Without a clear budget for 2024 by some new projects running at the WKSF, was not possible to approve a budget for 2024. All agree to move and step it. Without a clear budget, didn't exit anything to be approved or to be approve without any accuracy on financials.

#### 4) Choice of locations for the WKSF World Championship 2025, WKSF Open European

Championship 2025, WKSF Open Asia-Ocenia Championship 2025, WKSF Open North America Championship 2025, WKSF Open South America Championship 2025, WKSF Open Continentals Cup 2025, WKSF World Cup 2025;

Was presented to all members the actual situation in Europe, with election running the actual period, some members are waiting for next weeks to understand the way to host an European or World Championship during next year and also in 2026 or 2027. Representatives from Hungary, England, Brazil, India got voice and express the wish to host a World Championship. Other members got voice to share opinions and was decided to wait a couple of weeks to share the official Agenda 2025.

# Under a timeline to run the 12th General Assembly by other commitements at the World's 2024 Agenda, was decided to go over the 5) and 6) and present a discussion on item 7).

The WKSF under the analysis of all Results Reports and Registrations, understood that a lack of athletes, at 30 minutes Only Snatch competition, specifically on Elite. By this way, it was proposed a test to include the discipline of 12 minutes Only Snatch multi shands switch during next events in 2024. After this test, the WKSF must decide if include and remains with the 30 minutes Only Snatch or remove it and only brings the 12 minutes Only Snatch discipline. Over severeal minutes of discussion, it was approved my majority to test during next events in 2024.
