WKSF GENERAL MEETING MINUTE

At 7th December of 2024, at 17:30 pm at Sport Complex Pescara “Pala elettra”, via Elettra, 25-55, 65126, Pescara, Italy. WKSF General Meeting was started to discuss and deliberate the following Orders of Day:

- 1) President summary of the year 2024, recognition of national organizations.
- 2) Choice of locations for the WKSF World Championship 2025, WKSF Open European Championship 2025, WKSF Open Asia-Oceania Championship 2025, WKSF Open North America Championship 2025, WKSF Open South America Championship 2025, WKSF Open Continentals Cup 2025, WKSF World Cup 2025;
- 3) Discussion regarding competitions organization costs and competitions registrations.
- 4) Discussion of disciplines Snatch 12' and relay (changes on the rules)
- 5) Disciplines with single Kettlebells and Body weight Categories.
- 6) Memberships following the Regulations (representatives, references) and miscellaneous.

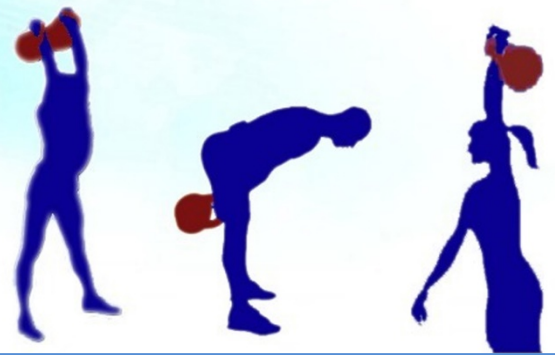
It assumes the presidency, according to the statutes, Mr. Ilika Oleh, president of WKSF Executive Committee, which saw the regulation of the convening of the assembly.

Are present at the meeting 9 countries, representing: England, Germany, Ireland, Italy, Hungary, Moldova, Poland, Portugal, Scotland and Ukraine, with a total of 16 votes + 4 from the Executive Committee represented by Mr. President Oleh Ilika, the Secretary General Eduardo Fonseca, Mr. Yaremus Andriy and Mr. Christian Borghello as members of the Executive Committee, for a total of 20 votes at the meeting.

The President proceeded to open the discussion of Orders of Day.

1) President summary of the year 2024, recognition of national organizations.

Mr. President presented the global situation of the WKSF during 2024. Congratulating the huge effort of all representatives and organizers of all competitions at the WKSF Agenda 2024. Also a global panorama of the various Continents efforts and reality. Mr. President congratulated all knowing that is necessary more commitment and effort to keep the high standards of WKSF.



2) Choice of locations for the WKSF World Championship 2025, WKSF Open European

Championship 2025, WKSF Open Asia-Oceania Championship 2025, WKSF Open North America Championship 2025, WKSF Open South America Championship 2025, WKSF Open Continentals Cup 2025, WKSF World Cup 2025;

Was presented to all members the actual and global situation. Was presented the candidature of the Moldova Member to organize the WKSF Open European Championship 2025. After a few words of Mr. Prodan Dumitru and by majoraty was accepted to organize it during 4th to 7th of December of 2025 in Chishinau, Moldova.

Also, by majoraty was accepted to organize the WKSF World Championship in Italy at the city of Busto Arsizio during 5th to 8th of june of 2025, however, by reasons out of WKSF and out of the Italian member, the 100% confirmation will be announced until the end of 2024 by the Italian member.

For the WKSF Asia/Oceania Championship 2025, the WKSF is waiting the confirmation of 2 candidatures, to host the competition in India or in China (Shangai). The confirmation will be announced until the end of 2024.

For the American Continent, was presented a suggestion to merge the WKSF Open North&Central Championship with the WKSF Open South Championship. The lack of countries in both areas may bring only one main competition every year with a WKSF Open All American Continent Championship. The situation will be discuss with all parts and will be presented the local and date of the competition for 2025.

Also, the WKSF Open Cups will be announced, with the confirmation of the WKSF World Cup 2025 to be hosted in Italy, Catanzaro in March.

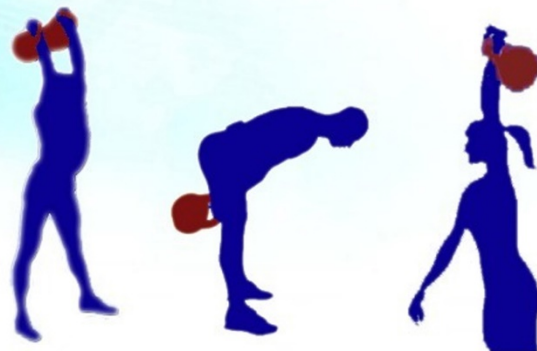
During the meeting, was presented a project to also included on WKSF Agenda a European Cup, with the leadership of the WKSF Operational Vice-President for Continent of Europe Mr. Yaremus Andriy to organized in 2025 the 1st WKSF Europe Cup in Slovakia.

3) Discussion regarding competitions organization costs and competitions registrations.

Mr. President presented the actual position of WKSF at the international panorama level. During WKSF network with all partners, with the actual incomings and expenses, with the vision of WKSF to bring a candidature to AIMS and also to WADA, with the project "Sport For All", with the Youngs, Disables and Africa Continent as priority, it was necessary to present and accept new ways of WKSF get more funds. Since the WKSF foundation, the Board Direction and the Executive Committee didn't raise up any fee and was decided to think about and bring a proposal to all.

After listening all wanted to express an opinion, lit was proposed by Mr. Matteo Castiglioni of Italy and Mr. Yaremus Andriy from Ukraine and for all categories Members paying the Annual Fee, to raise up the payment:

. World Championship Athlete Registration from 80€ to 100€ for all 1st discipline registration and remain all additional registration with 80€ payment.



. Continental Open Championship athlete Registration from 70€ to 85€ for all 1 discipline registration and remain all additional registration with 70€ payment. All Continental Open Cups and World Cups remains with 70€ registration fees as usual without any change.

. All other registrations for Members without Annual Fee payment and Non Official Members, the raise up will be propocional and announced in each WKSF Application Regulations for each competition.

All presented raised up hand to vote and by majority of 16 votes against 4 abstention, the proposal received order to be implemented. However, as the 13th WKSF General Meeting, a valid WKSF General Meeting for any decision, hosted at the European's, open and broadcasted alive to all members but with some members not present, it was decided to also share the suggestion and explain it to all members by email.


After a long explanation on previously point on agenda, it was presented the point 5) of General Meeting agenda.

4) Disciplines with single Kettlebells and Body weight Categories.

It was given to all the situation of some different disciplines between Females and Males during the competions, with Male Elite without the discipline of One Arm Long Cycle and Only Snatch, as Juniors on both genders female and male, just having the disciplines of Biathlon and Two Arms Long Cycle.

After some discussion presenting the facts of an important decision of Equality disciplines between both genders, was presented as a vision to be presented to all WKSF members as Questionnaire (by email) with several options to be approved until the end of 2024, to apply it in all 2025 events.
